

**Q/A to the works tender dossier CB 007.1.21.040-LP " Reconstruction of common shool yard".**

<p>1. Information about the tenderer's technical qualifications. This information must follow the forms in Volume 1, Section 4 of the tender documents and include:</p> <ul style="list-style-type: none"> <li>• a list of plant for execution of the contract. The descriptions must demonstrate the tenderer's ability to complete the works and should include amongst others, the following elements: <ul style="list-style-type: none"> <li>➤ Bobcat excavator - 2 pcs</li> <li>➤ Truck with load at least 10t - 1 pcs</li> <li>➤ Portable concrete mixing machine - 1 pcs</li> <li>➤ Concrete laser levelling machine - 1 pcs;</li> </ul> </li> </ul> <p>And under point 12.2.6. - The tenderer must have the necessary technical capacity, i.e. machines, equipment, to prove that he can fulfill the works. 4.	<p>In Volume 1., Section 1. INSTRUCTIONS TO TENDERERS; under part 12. INFORMATION/DOCUMENTS TO BE SUPPLIED BY THE TENDERER, paragraph 12.2.4, which is related to relevant experience of the tenderer, and which states: The tenderer must have successfully completed as prime contractor at least two (2) works contracts of concrete stamped works with executed area of 3 500.00 m<sup>2</sup> minimum each of them which were implemented during the last 8 years from the submission deadline, and in the following text says that If a tender is submitted by a consortium the selection criteria of point 12.2.4 for technical and professional capacity will be applied for the lead partner of the consortium. If a candidate/tenderer has implemented the projects in a consortium, the percentage that the candidate/tenderer has completed must be clear from the documentary evidence, together with a description of the nature of the works provided if the selection criteria relating to the relevance of the experience have been used.</p> <p><b>Question:</b> Does this mean that, in this case, the contractor for stamped concrete works, who is the carrier of these references, have to be also the lead member of a consortium, considering that the stake of stamped concrete works in the whole project of reconstruction of common school yard is less than 50% of the project as a whole?</p>	<p>As stated in Instructions to Tenderers point 12 INFORMATION/ DOCUMENTS TO BE SUPPLIED BY THE TENDERER, sub-point 12.2 if a tender is submitted by a consortium the selection criteria of point 12.2.4 for technical and professional capacity will be applied for the lead partner of the consortium.</p> <p>The requirement under point 12.2.4. has to be proven by at least two references/provisional/final acceptance/ taking over certificate or equivalent certificates of concrete stamped works with area of 3 500.00 m<sup>2</sup> minimum each of them issued by Contracting Authority/ Employer/Client/Engineer clearly indicating the date of issuing of the aforementioned certificates.</p>
